<b>Main Duties</b>	
To provide targeted support to pupils with special educational needs and disabilities (SEND), enabling access to learning and promoting independence. The postholder will work under the guidance of teaching staff and the SENDCO, supporting individual pupils and small groups, and contributing to the development of inclusive practices across the school.

<ul style="list-style-type: none"> <li>• Provide tailored support to pupils with SEND, including those with EHCP's.</li> <li>• Assist pupils in accessing the curriculum through adapted resources and differentiated activities.</li> <li>• Promote independence, confidence and self-esteem in pupils with additional needs.</li> <li>• Support pupils with personal care, mobility and therapy programmes, as required.</li> <li>• Monitor and record pupil progress, behaviour and engagement, reporting to the SENDCO and class teacher.</li> <li>• Support pupils during transitions including arrival, departure and movement between activities.</li> </ul>
